The candidates belonging to Other Backward Classes included in this list who are required to produce Non- Creamy Layer Certificate as per G.O (P) NO. 81/ 09/SCSTDD dated 26/09/2009 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate/ Non-creamy Layer Certificate will not be entitled to the benefit of communal reservation and will be considered as open competition candidates.

According to the existing procedure Re-valuation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts only after the approval of the Ranked List for the post.
