**NOTIFICATION**

The following list contains the names of candidates found suitable by the Commission on the basis of the result of the Objective Type Test (OMR) held on 24.02.2011 and followed by a physical measurement and practical test held on 20.11.2012, 21.11.2012 and 22.11.2012 for selection to the post of SEAMAN (NCA-EZHAVA, MUSLIM, LC) on Rs. 5250-8390 in Port Department in Kollam District, arranged in the order of merit. The Ranked List is brought into force with effect from 22.04.2013. The Ranked List will be in force until the candidates are advised and appointed against the vacancies earmarked for Ezhava, Muslim & LC Communities, but remain unfilled due to the paucity of candidate during the currency of the Ranked List published for the post on 20.04.2007 in Kollam District.

All the candidates participated in the practical test were included in the Ranked List for the above post.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs. 50/- (Rupees Fifty only) . The fee should be remitted in any one of the Treasuries in the State under the Head of Account “0051 PSC 105 STATE PSC 99 EXAMINATION FEE”. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website [www.keralapsc.org](http://www.keralapsc.org) or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the **District Officer, KPSC District Office, Andamukkam, Kollam** within 45 days from the date on which this Ranked List is published by the Public Service Commission. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain Photocopy of their Answer Sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 200/- (Rupees two hundred only) by way of chalan in any one of the Treasuries in the State ( Head of Account “0051-PSC-800 Other receipts-99-Other receipts” ). The duly filled up application in the Prescribed form (available from the Commission’s website) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Andamukkom, Kollam**. Copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued.

Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of Answer Script addressed to **District Officer, KPSC District Office, Andamukkom, Kollam** shall reach this office within 45 days from the date on which the Ranked List has come into force (ie, the date on which the Ranked List has been approved by the Commission).

**The last date for receipt of applications for rechecking/obtaining photocopy of Answer Script is 05.06.2013. Application for rechecking/obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.**
