- 1 **Department** : Thrissur Corporation (Electricity wing)
- 2 **Name of post** : Electricity Worker (Mazdoor)
- 3 **Scale of pay** : ` 3050– 4580/-
- 4 **Number of vacancies** : 20 (Twenty)

NOTE:- (i) The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance to this Notification shall remain in force for a minimum period of one year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked list.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

5 **Method of appointment** : Direct Recruitment

6. **Age limit** : 18-35. Only candidates born between 02.01.1976 and 01.01.1993 (both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation

Note:- The provisional hands working in the KSEB will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the

concern and shall produce the same as and when required by the commission. It would also be clearly specified in the certificate that they were not working in the regular Service of the Board.

7. Qualifications : -

- 1) Candidates should have passed Standard IV and should not have passed Standard X.
- 2) Knowledge of Cycling
- 3) Physical Standards :
 - a) Minimum height :- 5' 2" (157.48 cm)
 - b) Vision without glasses :- Normal (free from colour blindness)
 - c) Must be Physically fit for outdoor work.

(A Medical Certificate obtained from a Medical officer not below the rank of an Assistant Surgeon in the form appended below is to be produced at the time of interview to prove Physical Fitness)

Note:- Women and Physically Handicapped persons are not eligible to apply for the post.

8. The applications shall be submitted On-line only. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
