**Note:-** (i) Conventional type applications will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz [www.keralapsc.gov.in](http://www.keralapsc.gov.in).

(ii) Applications submitted by candidates belonging to the communities other than that included in this Notification will be summarily rejected. No rejection memo will be issued to these candidates.

(iii) A Ranked List will be prepared for Pathanamthitta and Palakkad Districts in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post as mentioned below in the Districts concerned.

(iv) Second NCA notification is issued due to the paucity of candidates belonging to the above community after the issuance of first NCA notification vide Cat No.319/16 (for OX) and 315/16 (for ST)

(v) The candidates belonging to above reservation community shall submit application for this post to the above districts and shall note the name of that district against the relevant column

in the online application.

(VI) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subjected to the rules in G.O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment :- Direct Recruitment (From candidates belonging to O.X and ST Communities only).

6 Age Limit

1. Indian Systems of Medicine / Insurance Medical Services

- (I) ST: 18-41 Only Candidates born between 02.01.1977 and 01.01.2000 (both dates included) are eligible to apply for this post in the case of Scheduled Tribe.  
(Including the relaxation as per para 2(i) of the General Conditions)
- (ii) OX: 18-41 Only Candidates born between 02.01.1977 and 01.01.2000 (both dates included) are eligible to apply for this post. In the case of OX Candidates who have converted to Christianity from Scheduled Caste Communities after attaining the age of 18 years and the children of such parents.  
(Including the relaxation as per para 2(i) of the General Conditions)

2. Ayurveda Colleges

- (i) ST: 19-41. Only Candidates born between 02.01.1977 and 01.01.1999 (both dates included) are eligible to apply for this post in the case of Scheduled Tribe.  
(Including the relaxation as per para 2(i) of the General Conditions)
- (ii) OX-19-41 Only Candidates born between 02.01.1977 and 01.01.1999 (both dates included) are eligible to apply for this post. In the case of OX Candidates who have converted to Christianity from Scheduled Caste Communities after attaining the age of 18 years and the children of such parents.

(Including the relaxation as per para 2(i) of the General Conditions)

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification (except para 2(i)).

7. **Qualifications:-**

1. Indian Systems of Medicine / Ayurveda Colleges

(i) Pass in SSLC or equivalent qualification.

(ii) Diploma/Certificate in Ayurveda Pharmacist course recognised by the Government of Kerala.

2. Insurance Medical Services

Certificate of Ayurveda Pharmacist Course recognised by the Government.

Note:- KS&SSR Part II Rule 10 a(ii) is applicable for selection to this post.

8. Mode of submitting Applications :-

Candidates must register as per “ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission, viz, '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as I.D Proof in their profile.**
