NOTE: (3) Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fees of Rs 200/- in any of the treasuries in the state (Head of account 0051 PSC 800 other receipts 99 other receipts). The duly filled in application in the prescribed form (available from the Commissions website) along with the original chalan should be submitted to the **Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram 4** on or before **07.06.2013**. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE: (4) A period of 45 days time for rechecking of answer scripts will be allowed to candidates with effect from the date of approval of ranked list. The candidates can avail only one chance after approval of ranked list. Applications for rechecking of answer scripts should be submitted in the prescribed form (available from the Commissions website or from enquiry sections of the offices of the Commission). Applications submitted in any other manner will not be considered.

The application for rechecking along with the original chalan receipt for the prescribed fee for Rs 50 under the head of account “0051 PSC 105 State PSC 99 Examination Fee” addressed to the **Deputy Secretary (Examinations) Kerala Public Service Commission, Pattom, Thiruvananthapuram 4** should reach the office on or before **07.06.2013**. Application for rechecking received after the prescribed time limit and not in the prescribed form will not be entertained and fee once remitted will not be refunded.
